Affidavit of Status: Living on the Land with Sovereign Identity and Sovereign Rights

Maxim of Law

Affidavit of life and sovereign identity

and still living on the land;

in the 28th minute passed the 19th hour;

on the evening of the 05**nd** day of the **12st** month known as **December**; in the year known as **1983** Anno Domini; at the approximated location of **Bærum**;

in the nation at that time known as **Norway**; with a free mind, free body, and free soul with creator/nature given properties I claim such creator/nature given and unalienable sovereign rights not surrendered nor abandoned any claims of life nor of any and all claims of estate.



Natural rights are universal: Rights are principles and as such are principle to law

Creator/nature given rights are rewarded as unalienable fundamental principles of absolute sovereignty to every born sentient being. Principles are principles – they come first. Before any man made or technology made or enforced rule. If a law, rule, mandate violates a right, that law, rule or mandate is null and void. It is invalid even in the eyes of the law. Because a law can never rise above a fundamental principle which is a right. A law can derive from a right, but it cannot move above the right. So any violation of a right is worthless.

By being born, every sentient being has the creator/nature given right for oneself, one's offspring and one's family – to live and roam freely across lands and air and waters as long as one intends to cause no harm, no loss, nor injury to another and as long as one stands honourably in all ones dealings including yet not limited—

to life and the right to live and to ensure one's survival – including yet not limited to water, air, food, clothing, shelter;

to be free – including yet not limited to freedom from captivity, slavery, involuntary servitude, invasion, coercion, force or tyranny;

to safety and security – including yet not limited to feeling safe in one's own home and anywhere else;

to privacy and confidentiality – including yet not limited to free from unwarranted invasion;

to roam – including yet not limited to freedom of movement and to travel lands, air, waters in the ordinary coarse of one's life and business;

to self-sovereignty – including yet not limited to make personal choices, determine actions and reactions, exercise exclusive authority over one's actions and reactions;

to self-defence – including yet not limited to protect oneself from harm, loss, deceit, injury, death, torture, force, tyranny and oppression by all means and including violence;

to bodily autonomy – including yet not limited to seek care, to refuse care, and to administer self-care and to accept or refuse supervision, observation, testing, treatment, and medication;

to one's life creations – including yet not limited to make good use and living from one's own time and attention and energy and knowledge and skills and talents and strengths and experience and associations;

to expression – including yet not limited to freedom of thought, speech, and the practice of religion and peaceful protest;

to association - including yet not limited to assemble or organise or collaborate or enter into agreements;

to contract or not to contract, which is unlimited;

to due process of law – including yet not limited to due notice and opportunity to defend;

the right to be presumed innocent, suffering no detention or arrest, no search or seizure, without reasonable cause;

to remain silent when accused to avoid self-incrimination;

to equality in the eyes of the law, and to equal representation;

to trial by jury being an impartial panel of one's peers;

to appeal in law against conviction or sentence, or both;

to expose knowledge necessary to one's rights and freedoms;

to practice a religion and to have beliefs, of one's choosing;

to love and to consensual Private or affiliated marriage with offspring, as a family;

to refuse to kill under command, by reason of conscience;

to live in peace and be left alone when causing no harm, loss, or injury to another and when standing in honour in all one's dealings;

to one's property as born and created – including yet not limited to all creator/nature given and developed physical, functional, chemical, and spiritual properties; as expanded

to one's offspring in present and in future as product of bloodline and to exercise exclusive authority over in all matters of life and death until offspring's coming of age and any time thereafter as next of kin and administrator in the event of offspring's incapacitation;

to body properties – including yet not limited to optical, acoustic, mechanical, surface, perspiring, thermal, electrical, magnetic, viscosity;

to body characteristics – including yet not limited to torso, arms, legs, feet, hands, face, hair, body hair, buttocks, reproductive organs, eyes, ears, nose, nails, skin folds, scars;

to biometric identifiers – including yet not limited to handprints and fingerprints, footprints and imprints of toes, voice characteristics and frequency, face design, irises, blood composition, hair composition, DNA, reproductive

cells and fluids, intestinal bacterial flora, heat emission, light emission, stem cells;

to body functions – including yet not limited to cardiac, renal, lungs, liver, gastro intestinal, thyroid, lymph, spinal fluid, nerves, salivary, blood, brain, reproductive organs;

to sentient being senses – including yet not limited to smell, taste, hearing, sight, pressure and touch, temperature, muscle and skeleton, and balance;

to critical emergency care in case of life or disability threatening emergencies without prejudice nor loss of rights, including yet not limited to the right of being resuscitated in case os loss of consciousness or life signs without regard to cost or priority consideration;

to after life property – including yet not limited to body organs, to be family property and not offered as grant, gift, nor for sale to any third party;

to control created identifiers for discretionary use in the public or private domain or both – including yet not limited to names, autographs, signatures, initials, and photographs and images of oneself or one's property; and

to seek remedy from each living being seeking to limit one's rights or freedoms or threatening, intimidating or causing loss or harm; and

as product of original creation never been and can never be any type of Person/PERSON (from Latin 'persona' meaning mask, false face or assumed character'), and therefore exempt from any and all indemnifications, treatments and requirements, as such, pursuant to any man-made legal process, law, code, statute, or any colour thereof; and

I am not a 'Citizen', 'Resident', 'Subject', 'Taxpayer' et al. I cannot ever accept any title or personage given to me by any man or woman, whether acting individually or in any capacity as, or under any Artificial Person, Agency, Entity, Officer or Corporate Party of any kind, nor does my physical location or the location of my Private Property ever create any duty or obligation upon me or my Property to any aforementioned Corporate Party or Parties, which are Fictions of law that possess no authority or right in any case whatsoever to make claims over or against myself or my Property; and

I am the sole responsible party and holder in due course for the Private Property referenced above as well as in any declared Property. I hereby fore-claim any future Biological Property conceived within my body by the aid of my Creator and with a man, whose joint Biological Property any corresponding future conception(s) should also be considered. Any change to my biology altering its properties and/or functions and/or identifiers and/or reproductive

cells by any other than me are entirely unintended and do not constitute any claim to nor control over same by another; and

I do not consent to be compelled, manipulated, extorted, tricked, threatened, placed under duress, coerced or in any other way so affected under colour of law by any man or woman, whether acting individually or in any capacity as, or under any Artificial Person, Agency, Entity, Officer, or Party of any kind, into waiving any of my Rights which are my Personal Property bestowed upon me when born or to act in contradiction to any or all of the above rights;

I waive none of my creator/nature given, unalienable rights endowed upon me at the time of my creation.

These above sovereign rights extend beyond one's own or one's offspring's or one's family's incapacity or death.

Notice and Proclamation

I hereby terminate any third party living being or person or fiction claims or loss of status on myself, my offspring, my family or any of our property—including yet not limited to any securitised birth certificate or liens in my legal or real person name. All such contracts are null and void as they were made on our behalf without our knowledge or under duress or without equal consideration or without lawful right to enter into such agreements. I henceforth take full responsibility for property and any beneficiary proceeds and claim full capacity as creditor and accept full liability for my own actions.

Oath: I stand under Natural Law

As per my universal rights, I am responsible for my own life experience. I am liable for the effects of my life actions. Being born evoked my Natural Law as inalienably rewarded freedoms to all living sentient beings. I thus stand under and will uphold these laws as I require of any man and woman—I intend to cause no harm, injury or loss.

I stand in honour in all my dealings.

Without prejudice

Performance or acceptance under reservation of rights, a party that with explicit reservation of rights performs or promises performance or assents to performance in a manner demanded or offered by the other party does not thereby prejudice the rights reserved.

I retain all of my rights and liberties at all times and in all places, from the time of my birth and forevermore. Further, I retain my rights not to be compelled to perform under any contract or commercial agreement that I did not enter knowingly, voluntarily and intentionally. And furthermore, I do not accept the liability of the compelled benefit of any unrevealed contract or commercial agreement. I am not ever subject to silent contracts and have never knowingly or willingly contracted away my sovereignty.

Right to amend

I am not an expert in the law however I do know right from wrong. If there is any human being damaged by any statements herein, if he will inform me by facts I will sincerely make every effort to amend my ways. I hereby and herein reserve the right to amend this document as necessary in order that the truth may always be ascertained and upheld, and all proceedings justly determined. If any party given notice by means of this document have information that would controvert and overcome this Affidavit, please advise me by autographed counter-affidavit in person or by e-mail within 72 hours of the receipt thereof, proving with particularity by stating all requisite actual evidentiary facts, and all requisite actual law, and not merely the ultimate facts or conclusions of law, that this Statement in the form of an Affidavit is substantially and materially false sufficiently to change materially my status and factual declarations. Silence after 72 hours stands as consent to, and tacit approval of, the factual declarations herein established as fact as a matter of law. Documents sent or delivered to a physical mail box, another man/woman, or to any artificial Person of Office will not be regarded as legitimate rebuttal. Failure to address or deliver documents properly and as requested will not be accepted as an excuse for missing the 72 hours deadline.

Amendments will be added to original affidavit records and attested by witnesses via digital autograph backed by original autograph and thumbprint or by proclaimed physical document amendment with autographs and thumbprints.

Corpus Juris Secundum Section 16, Page 892:

FACT OF DEATH: Death of the person on whose estate administration is sought is a jurisdiction requisite; and while the presumption of death arising from absence may present a prima facie case sufficient to warrant a grant of administration, yet if it subsequently develops that such person was in fact alive, the administration is void.

While it is true that the presumption of death arising from a person's absence, unheard from, for a considerable length of time, see "Death Section 6", may present a prima facie case sufficient to warrant a grant of administration on his estate, the arising of such presumption does not take the case out of the operation of the general rule on the subject, and if it is made to appear that the person was in fact alive at the time such administration was granted, the administration is absolutely void. Although, that payment to an administrator of an absentee who is not in fact dead is no defence against the absentee or his legal representative, nor are costs and disbursement incurred by such administrator a legal charge against the absentee or his property; but where the administrator has paid debts of the absentee, he is subrogated to the rights of the creditors whom he has paid. It has been considered, however, that the invalidity of the administration does not relate back, but that it is invalid only the time when the presumption of death is rebutted.
